- 1. Each person who wishes to reside in the property, and is over 18 years of age, must complete an application.
- 2. The application will not be processed until it is complete, and all applicants for the property have submitted applications.
- 3. Please ensure you have signed the tenant declaration and privacy consent (page 4).
- 4. We endeavour to process all applications in under 48 hours of receipt of your application.
- 5. Once the application has been approved you will be required to pay 2 weeks rent within 24 hours to secure the property. The payment is to be made by EFTPOS in office, bank cheque, money order or via SIMPLE RENT.

 Please note, this is not a deposit and is non-refundable in the event you change your mind.
- 6. All applicants must be present at the appointment to sign the lease, which is required within 24hours of being approved, to complete the relevant paperwork. At this point you will be required to pay the bond (usually 4 weeks rent). The payment is to be made by EFTPOS in office, bank cheque, money order or via SIMPLE RENT.

- 7. This office does not accept bond transfers and does not transfer Department of Housing Bonds.
